Dear Linda, I hope you have been with us ,of the 10 1/2 Years As , Your representative,gave up so quickly,Bill,put me in charge as a Dpof att,I did not ask for it ,but me , Tammy and Angie,He was a handful a lot of time and work.Had to get him,to quit ,was having silent heart attacks.I knew ,when you came on her to borrow that wedding dress ,Bill told me you were going to get married.But he said his insurance at work only covered \$275,000.i am so proud of you out living cancer.Having Medicaid was a blessing..Middle of 2014 no signs of cancer.And let your truck heal on its own.When I was over ,you were up the pool ,Lucy on floater,and you had a glass of you wine and a cig in the other,When I seen your gause,soaked,and said ,Linda you didn't go under,did you,She smiled,and said this is my life style..A few months later,she was in bed Around Nov2014,A booklet for her to read ,learning and living and dying,Over a month 1/2 she was gone,We miss you dearly,and Bill said don't let him ,get my purse or ring .And he did.Linda said to us she was taking the house to the hill,and she did.Even though ,Bill signed and she did ,she had no means of funds.But she lived a very luxury lifestyle that is still ,not even paid for yet.Doing Bills taxes 4/1 2. Years later ,here's was hidden inside Bills A property tax credit. Then I had ask Chapel Hill who gave you my sister's SSN ? She said her oldest son Shane,I said how did he give that to you ,, Stephanie said on a piece of notebook paper,It did not match My sisters SSN,And Stephanie drove over here fast in 2 days and stuck new ones in mailbox It is also negligence of Stephanie,to take a SSN to bury someone,This was done intentionally,The Representative (explains why) she couldn't do anything and gave up Then we were told we had to do an affidavit of death of my sister's with real SSN.Linda was very nice and tidy ,and her SsN was in her purse and on government forms,As years went by no loans except Linda was taken out on this house,She lived the fullest to the end,and I wish I we had her back,We knew she couldn't stand her oldest,except he gave her 2 grandbabies she adore ..Bill towards 6 years,had a few girlfriends,and he loved Linda dearly,and said I To me you think about Linda ,more then. I do now. That hurt me,and him giving the pool away few months after she died,and said he didn't have to hang Christian Big lights anymore,that hurt But Bill took her to every chemo treatment,and also handed his check to my sister,Even though she could not eat,she made him a 6 course meal What a Betty Crocker my baby sister was, Medicaid usually wants their funds back,after a desease person.But with deliberately burying someone with A SSN to benefit themselves,is not good. She always called her first husband a tightwad..Well with many of claims on this home she made,And problems being fix and still on going ,it's very costly.Alot of Mice,rodents,roof,flooring,at her death ,I never knew the only appliance that worked was her stove.We were always partial. She was over mine or I was over hers.After Bill had to quit his job he upgraded furnace matching Central Air 50 water heater,even added a 4 ft water softener. Then got tired of carry salt

down steps. Then order an easy floor ,to replace. And got a \$3200 industrial refrigerator. All these items worked, he wanted everything with a solar energy sticker on it. Then I had to get a lawn service , as he almost ended up in street. A lot of work has been done, here in the last 10 years, and to hear the house shifted by Safeco, That was hard for me to believe, There's been very low offers on this house as it needs a updated roof, siding, decking, porch area, front right of bricks. Just had to tear Elephant Wall down , concrete was poured poorly over the drain in kitchen The deep whole all redone in driveway . All electrical smoke alarms dated 2011 , all had to be replaced Mold from older pump, was put in, Had to update the entire pump, because the pump that was first I started the drain was under ground . It is now coded the way a PC. Pipe should drain. My daughter s and I are missing bill, to the end as we helped pay for a lot between the 3 of us Bill needed , his beer , doctors , food, 5 years before his death we helped him, quite a bit. As it was to them their Uncle Bill. Linda I praise everything, when you and I were driving around looking at that old house next door And you bought it Very proud how you designed this one. But the engineering and electrical work was done poorly., And I do know that wasn't on your part. I was happy to be with you when you and I went on Manchester to order all lighting.. I and my daughters love and miss you , You a Joan Rivers and Lucille Ball. In !... There's a lot more , and the girls and I have been moving our belongings, back home . Gave quite a bit of items , furniture, set out in front that persons in need. We were and still are very close. I going back and forth and dealing with 2 houses is very hard . A lot of paperwork. But will put you in tomato plants in the near future, and remember you and I took ours to Sappington Gardens.. And you Won , I was happy for you. We all love you , and Linda we will meet again... I would sell my house and live here, but there's a lot of memories, and it needs a lot of work. whoever buys it , and put upgrades, more than 6 diff offers , and most persons all had the same conclusions. I don't have a house payment at my home, And I have turned down all loans . When they were offer or even anymore refinance, you were with chase 5.6 % , Bill I got it down to 3.85%.. No money was ever taken out , since you and Bill did take the house to the hill . Even Butch remembers you saying that, and a whole lot others. Except the person who only thought you owed \$50,000. Omy you did a fast one on him , you own son. Give ya a box of wine for as you told many, but not the boys and nothing has changed between them. Shawn still listens to Shane.. Oh well , there's pretty serious shit about The Medicaid, and your SSN ... I will take each diff 1 and put them in a balloon, to you... And all what I was told him going against your Divorce, you were right all along . MONEY.....
